CALL TO ORDER: Chairman G. Petriccione called the meeting to order at 7:39pm.

FIRST VICE CHAIMAN'S REPORT: There was no report given as the First Vice Chairman was absent from this meeting.

SECOND VICE CHAIRMAN'S REPORT: Second Vice Chairman B. Piepho stated the annual fish stocking is complete as of April 30, 2015. This year stocking included 616 Northern Pike; 412 in the Shepaug and 204 in the Bridgewater Town Park.

TREASURER'S REPORT: Treasurer L. Leaden stated that she received a letter from the insurance company. The rates will be increasing approximately \$5,900 due to the Workman's Compensation claim. The insurance policy will renew on July 1, 2015. She also stated that the bookkeeper is currently out of the country. Treasurer L. Leaden will take the responsibility of writing checks until the bookkeeper returns.

CHAIRMAN'S REPORT: Chairman G. Petriccione stated that the boats have been placed in the water. He also stated that he will check on the status of when buoys will be placed. Chairman G. Petriccione reported that Canterbury will have its rowing event on Saturday, May 16, 2015. Chairman G. Petriccione stated that the 2015 Grant Application has been completed and mailed on April 30, 2015.

NEW BUSINESS: Second Vice Chairman B. Piepho stated that daily water sampling will commence on June 1, 2015.
