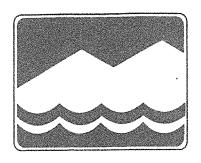

REGULAR MEETING MINUTES May 2, 2017 Brookfield Town Hall Room 209

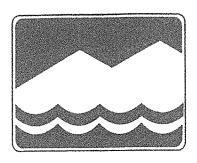
<u>CORRESPONDENCE</u>: Treasurer B. Woerner reported receiving correspondence from Southbury regarding the LLA audit. Chairman G. Petriccione reporting receiving communication from Southbury requesting he attend the next Southbury Board of Finance Meeting.

OFFICER REPORTS

CHAIRMAN'S REPORT: Chairman G. Petriccione stated that he met with Russell, CCA, regarding the placement of docks and tanks. He also stated that the new boat has arrived with minor alterations. These alternations will be performed locally. Chairman G. Petriccione stated that he will attend the May 8, 2017 Southbury Board of Finance Meeting, Southbury Town Hall, 7:00pm, along with Treasurer B. Woerner, S. Ivan, Bookkeeper, and M. Carrington. Chairman G. Petriccione reported that he has been in contact with Brian Wood regarding the buffer zone plan. He also stated that the Emergency Action Plan Meeting will be held this month.

FIRST VICE CHAIRMAN'S REPORT: First Vice Chairman S. Young reported that the buoys are in place. He also stated that a new buoy has been placed downstream of the gorge. This new buoy is a non-ballasted buoy. A permit will need to be executed. First Vice Chairman S. Young reported a bollard broken at the RT 133 boat launch. He stated that he spoke with our buoy vendor regarding water chestnut removal.

• Grant Update - B. Piepho stated that he is waiting for HRP Grant award to purchase bass stock.

A motion was made by B. Piepho, seconded by A. Michener, to approve tiger musky as a viable fish for Lake Lillinonah. Motion passes unanimously.

A motion was made by B. Piepho, seconded by W. Pelletreau, to approve \$2,700 for fish stock in the current budget and reallocate monies from water quality to benefit the health of the lake. Motion passes unanimously.
