CALL TO ORDER: B. Boodry began the meeting at 7:34 pm.

APPROVAL OF MINUTES: A motion was made by R. Carley, seconded by B. Woerner, to approve the LLA Meeting Minutes of January 3, 2012 as amended; under New Business, Officers, – change third line to read seconded by S. Ward instead of S. Young. Motion was passed unanimously.

OFFICER REPORTS:

<u>CHAIRMAN'S REPORT</u>: B. Boodry stated that the Board Member section on the website has been updated. B. Boodry asked all members to look over their information and report to J. Simmons any changes.

- S. Ward updated the Board of the new apartment complex in New Milford. These apartments are two stories and have either one and/or two bedrooms, with garage underneath apartment
