**BOAT AND SAFETY COMMITTEE:** Chairman S. Young reported on Boating and Safety for the month of August 2024 as follows:

## **Patrol Activities:**

There are 8 certified police officers, 8 lake patrol officers, and 1 new assistant for 2024. All three Lake Lillinonah Authority-furnished marine patrol boats are in service and available. 392 man-hours were assigned in August for patrol and used approximately 564 gallons of fuel. Several shifts ended early due to rain/thunderstorms this month. The patrol had 79 contacts with vessels, and camper/swimmers, which resulted in 48 warnings for assorted violations and 46 inspections primarily for life jackets. Patrol had 15 documented boater assists and 16 trespassing contacts at the Bleachery Dam and Rt 133 boat ramp.

R. Johnson , a newly appointed LLA Marine Patrol Assistant, stated that the patrol undertakes more responsibilities than is reported.

FISH STOCKING COMMITTEE: Chairman S. Young reported that C. Read caught a giant Tiger Muskie in the Lake.

**ANY OTHER ITEMS TO BE DISCUSSED**: Chairman S. Young stated that Josh Francis has been appointed as the new President of FOTL.
